APPLICATION FOR SENIOR CITIZEN DISCOUNT ON WATER SERVICE USE FEES

Beginning September 1, 1994, the District is pleased to offer a senior citizen rate on water service use fees. The senior citizen rate shall be discounted by 50% of the base rate only, i.e. \$13.50 for usage of 9,000 gallons per month or less. The District's current base rate is \$27.00. Fees for usage over 9,000 gallons per month will continue to be billed at current metered rates and no discount shall apply to usage over 9,000 gallons per month. This discount shall be given to persons who meet the following criteria:

1. That the owner(s) ("qualified party") of the subject property be sixty-five (65) years of age or over and provide to the District proof of age. Owner shall mean the person or persons in whose name the subject property is titled. In the case of husband and wife, only one must meet the age criteria. In the case of unrelated persons, all parties must meet the age criteria. Proof of age may be a Colorado Driver's License or Identification Card, Birth Certificate, Passport, etc.
2. That the qualified party is a full time year-round resident of the subject property.
3. That no portion of the subject property be rented or leased to any other person or entity at any time.
4. That no commercial (business) entity be operated out of the subject property by any person who is a resident of the subject property at any time.
5. That the qualified (or spouse) is responsible for payment of use fees.
6. That the qualified party make application for the senior citizen discount rate.
7. That the qualified party agree to report to the District, within ten (10) days of the occurrence, any change in ownership or circumstance that would cause the discounted rate to no longer apply.
